

**TERMS AND CONDITIONS**

**AfriSam (South Africa) (Pty) Ltd's "Win'a Plenty Plenty" Competition – 2022  
("the Competition")**

## TERMS AND CONDITIONS

1. The Competition is organized by AfriSam (South Africa) (Pty) Ltd (“AfriSam”).
2. By entering the Competition, all entrants, participants and winners agree to be bound by these rules (which rules will be interpreted by AfriSam and whose decision regarding any dispute will be final and binding).
3. AfriSam reserves the right to amend, modify, change, postpone, suspend, cancel the Competition and any Prizes as defined in 6 below (which have not yet been subject to a draw), or any aspect thereof, without notice at any time, for any reason, which AfriSam reasonably deems necessary.
4. The Competition commences on 1 May 2022 and ends on 31 July 2022 at 00h00 (“the Competition Period”).
5. The Competition is open to permanent residents and citizens of South Africa over the age of 18 years and in possession of a valid South African identity document excluding any director, member, partner, employee, agent, service provider or consultant or any person who directly or indirectly works with AfriSam and/or immediate family members of any employee, director, member, partner, agent or consultant of or any person who directly or indirectly deal with AfriSam, its advertising agencies and its advisers or organisers of this Competition.
6. The Competition includes the following prizes, which participants stand a chance to win:
  - 6.1. **Daily Prizes**
    - 6.1.1. 661 x daily cash prizes are available to be won over the Competition Period (in denominations of R100, R200 and R500) which will be redeemable at any Standard Bank ATM) (“the Daily Prize/s”).
    - 6.1.2. Participants can win a Daily Prize more than once.
  - 6.2. **Monthly Cash Prizes (which are available to be won monthly, and shall be awarded over the Competition Period):**
    - 6.2.1. 30 x R10 000 monthly cash prizes are available to be won over the Competition Period (being 10 cash prizes of R10 000 each per month) (“the Monthly Cash Prize/s”) and will be paid to the winners via an electronic funds transfer (“EFT”).
    - 6.2.2. AfriSam will require all relevant information and documentation from the winner in order to validate the payment by EFT, and the winners will be obliged to provide such information and documentation to AfriSam in order to claim the Monthly Cash Prize.
    - 6.2.3. Participants can only win a Monthly Cash Prize once.

(the Daily Prizes and the Monthly Cash Prizes are hereinafter collectively referred to as “the Prize/s”).

## 7. Entering the Competition

7.1. To enter the Competition for the **Daily Prizes and/or the Monthly Cash Prizes**:

7.1.1. The participant must send his/her till slip, indicating that a minimum of 5 (five) bags of selected AfriSam All Purpose Cement 50kg bagged product (“the Participating Product”) have been purchased by the participant, via Whatsapp to 087 240 5550.

7.1.2. The participant must retain proof of the purchase referred to in 7.1.1 above in order to claim the Daily Prize and/or the Monthly Cash Prize (as applicable).

7.1.3. AfriSam shall verify the validity of the till slip sent by the participant in terms of 7.1.1 above and, if it is found to be invalid, the participant’s entry will not be included in the draw for the Daily Prize and/or the Monthly Cash Prize (as applicable).

(the entries referred to in 7.1 above are hereinafter referred to as “Entry” or “Entries”, as applicable).

7.2. Entries which are unclear, illegible, submitted via an incorrect mechanism, contain errors or are from disqualified persons will be declared invalid.

7.3. The participants may enter the Competition as many times as they wish by utilizing the entry mechanisms described in 7.1 above, provided that:

7.3.1. in relation to Entries for the Prizes, the Entry indicates the purchase by the participant of a minimum of 5 (five) bags of the Participating Product during the Competition Period and proof of purchase is supplied in terms of 7.1.2 7 above; and

7.3.2. participants can only win a Monthly Cash Prize once.

8. Any Entries received after the closing date and time stipulated in 4 above will not be taken into consideration.

9. All Entries received for the Daily Prizes will be verified to ensure that the participant’s till slip indicates the purchase by the participant of a minimum of 5 (five) bags of the Participating Product within the Competition Period. All valid Entries for the Daily Prizes will then be entered into a pool where the winners will randomly be drawn and notified that they have won a Daily Prize and that they will receive an SMS from Standard Bank to redeem the Daily Prize. Winners of the Daily Prizes will then receive their funds via Standard Bank’s Instant Money Service in terms of which the winner will.

9.1. receive a unique pin number via SMS;

9.2. be sent a second unique pin number from Standard Bank within 24 hours (if not instantly).

9.3. be required to go to any Standard Bank ATM to claim the Daily Prize, select cardless cash withdrawal and enter both pin numbers (whereupon they will receive the Daily Prize).

10. Winners do not need to have a bank account with Standard Bank in order to claim the Daily Prize and will have 30 days (from the date upon which they received their pin numbers to claim the Daily Prize from Standard Bank. 11. Monthly Cash Prize draws will, unless otherwise communicated by AfriSam in its sole discretion, take place between the 1<sup>st</sup> and the 12<sup>th</sup> of the month over the Competition Period.
12. AfriSam and/or its advertising agents will contact the Monthly Cash Prize winners, via SMS/telephone. AfriSam or its agency will endeavor to contact each Monthly Cash Prize winner 3 (three) consecutive times using the cellular number as per the Entry. Should the winner not respond within 48 (forty-eight) hours of the first attempt at contact, the Monthly Cash Prize will be forfeited and another winner will be selected as per 11 above.
13. In the event of any dispute arising in relation to the interpretation of the Competition rules, AfriSam's decision is final and no correspondence will be entered into with entrants, participants or winners in this regard.
14. All participants and the winners, as the case may be, indemnify AfriSam, its advertising agencies, advisers, nominated agents, suppliers, its affiliates and/or associated companies against any and all claims of any nature whatsoever arising out of and/or from their participation in any way howsoever in this Competition (including as a result of any act or omission, whether as a result of negligence, misrepresentation, misconduct or otherwise on the part of AfriSam and/or use of the Prizes).
15. The Prizes shall not be transferable and AfriSam reserves the right to substitute any Prize with another prize of comparable commercial value.
16. By entering this Competition, the participants authorise AfriSam and its promoters, to collect, store and use their personal information for communication or statistical purposes, and consent to the dissemination of such personal information to AfriSam's authorized agents and suppliers for purposes of redeeming the Prizes contemplated in the Competition. AfriSam undertakes to process such personal information and that contemplated at 21 below in line with the provisions of the Protection of Personal Information Act, 2013.
17. AfriSam and their agents reserve the right to cancel, modify or amend the Competition at any time, if deemed necessary in its opinion, and if circumstances outside of their control should arise.
18. AfriSam shall not be responsible for any changes, substitution, withdrawal, cancellation or postponement of any part of the Prizes beyond its control and AfriSam shall not be obliged to award any other Prizes in lieu thereof.

19. If a dispute as to the identity of the winner of a Prize arises, the owner of the cellular handset in question will be deemed the legal winner of the Competition, irrespective of who entered using the handset. Entries are represented and identified by the cellular number used to enter. AfriSam shall not take any responsibility for users of handsets not belonging to the person in question.
20. AfriSam will require the winner of the Monthly Cash Prize complete and submit an information disclosure agreement and indemnification to enable AfriSam to ensure compliance with these rules and the Consumer Protection Act 68 of 2008. Should the winner refuse or be unable to comply with this rule for any reason, such winner will be deemed to have rejected the Monthly Cash Prize and it shall revert back to AfriSam.
21. By entering this Competition, the participants consent to AfriSam photographing them and publishing their names in any printed media, or any other relevant media, to the extent that they are the winner of a Prize. When accepting the Prize, the winner must indicate to AfriSam should they not want their images or name to be published and AfriSam will then not proceed with the publication of same.
